Insurance Cover

Public Liability and Personal Accident insurance provided for the school by CWAC does not cover pupils or helpers at Queen's Park High School rowing club. This is because the club is run entirely by volunteers and not by a member of staff. The club therefore pays for its own **Public Liability Insurance**. This covers all club officials, members and helpers up to £2,000,000.

There is no personal injury component of this policy and all rowers are advised to join **British Rowing** (BR). Membership of British Rowing provides personal accident insurance cover of up to £50,000 and civil (public) liability cover of £5,000,000. Membership is required in order to compete at events and also includes ten colour magazines a year. All coaches are also members.

You can apply and renew easily online on the British Rowing website.

(Rowing is a very safe sport and the club has never had a claim for injury.)
